**Attention: Regular changeover of the producer price index to the new base year 2021**

The index of producer prices of industrial products will be converted to the new base year 2021 with the reporting month January 2024. The first publication of the results on the new basis has been announced for March 8, 2024 on the website of the Statistisches Bundesamt. The calculation of the DB Schenker diesel floater from 01.03.2024 (reporting month January 2024) is provisionally based on the report "Price for selected petroleum products January 2024, EVAS number 61241" of the Statistisches Bundesamt. This does not change the floater values, as both values (price of selected petroleum products and indices of producer prices of industrial products) correlate.
