### **Domestic**

With DB SCHENKER | parcel Domestic sending a parcel to companies in Sweden is simple, rapid and secure. You easily place your transport orders via your TA/system supplier or via <a href="www.dbschenker.com/se">www.dbschenker.com/se</a>. We handle the rest.

Below is the basic information applicable to domestic parcel consignments.

**Weight:** The maximum weight is 30 kg per parcel with a maximum of 99 kg per consignment.

**Volume:** The maximum volume per consignment is  $0.36 \text{ m}^3$  (1 m<sup>3</sup> = 280 kg).

**Maximum measurements**: Maximum length/parcel 2.0 m. Length + circumference may not exceed 3.0 m

**Minimum measurements:** Transport labels must fit fully on the top of the parcel, and the height of the parcel must be at least 20 mm.

**Heavy Parcel:** For items heavier than 20 kg actual weight a surcharge will be applied. We recommend, when possible, to split heavy items into smaller parcels under 20 kg.

**Non machine sortable**: In the case a parcels length exceeds 1,4 m or by other reason is deemed not suitable to be sorted by parcel sorting machine, an additional fee for non machine sortable is charged.

**Exceeded product conditions**: For parcels/shipments exceeding the above stated maximum measurements and weight limits, an additional fee is charged (see p. 15).

DB Schenker has no obligation to distribute goods exceeding the above product conditions, and DB Schenker therefore reserves the right to handle such goods in a different way than as stated in these special terms.

**Multi-parcel consignments:** Shipments with more than one parcel will be charged according to the minimum freight weight of 20 kg. For shipments with more than 5 parcels, a parcel supplement of SEK 15/parcel will be charged from and including the 6th parcel.

**Freight calculation**: Zone pricing applies (see price list). Freight haulage weight: Freight is calculated based on the freight haulage weight, i.e. the higher of the actual weight or the volumetric weight.

**Volume calculation**: The volumetric weight is calculated by multiplying the total volume of the shipment expressed in cubic metres with 280 kg.

Invoicing: The minimum charge per invoice is SEK 150.

**Timetable:** The timetable includes the locations and postcode areas we serve as well as current transport times in Sweden.

Collection: DB SCHENKER | parcel is collected following booking at your nearest DB Schenker office. If you book after 12 noon, the parcel is collected on the next day stated in the timetable. If there are fewer than five (5) consignments to be collected on the same occasion, there is a collection charge (unless collected at the same time as DB SCHENKER | system Domestic). Items with a weight below 20 kg and with maximum dimensions corresponding those for DB SCHENKER | parcel Shop can also be submitted to any of DB SCHENKER | parcel shops for a fee of SEK 15 per item.

**Distribution**: Delivery of parcels takes place according to the timetable to the stipulated delivery address, inside the company's door/gate or to a stated floor, reception desk or functioning incoming goods reception point. The consignee must be available during normal working hours, 07.00–17.00. If this is not the case the following alternatives are available:

- 1. Parcels can be collected from DB Schenker's terminal at an agreed time
- 2. Parcels can be delivered on payment of an extra charge following agreement with the consignee.

**Location surcharge**: Information about the postcodes and locations concerned together with location surcharges is available on our website <a href="https://www.dbschenker.com/se">www.dbschenker.com/se</a>

**City surcharge:** There will be a city surcharge for consignments to Gothenburg and Stockholm.

**Uncollected parcels**: Uncollected parcels are returned to the consignor after contact with them, at the freight-payer's expense, 15 working days after arrival at the receiving terminal. A storage charge may be payable. There will be a storage charge from day four (4), see page 15

**Supplementary conditions**: All goods must be packed in such a way that they can withstand normal mechanical sorting and transport. Fragile goods, liquids and paint should be packed in packaging approved by Förpackningskonsult\* and marked with a special "Fragile goods" label. Vessels containing liquids should also be embedded in an appropriate absorbent material.

### The following goods may not be transported as DB SCHENKER | parcel:

For **DB SCHENKER** | **parcel** domestically, only dangerous goods in limited quantities, according to Chapter 3.4 of ADR and lithium batteries according to special provision 188, may be transported. The goods must be acknowledged by the consignee. (Explosives, class 1 (except for UN 0014 tool cartridges), and corrosive liquids, under no circumstances may be sent as **DB SCHENKER** | **parcel**.) Sea transport of limited quantity of dangerous goods as **DB SCHENKER** | **parcel** is only accepted on the Swedish Transport Administration's ferries. This means that dangerous goods in limited quantity are not allowed to be sent as **DB SCHENKER** | **parcel** to and from Gotland, or to and from destinations that are not transported by the Swedish Transport Administration's ferries. This option is not allowed for individuals.

Dry ice (UN1845) and substances presenting a risk of asphyxiation when used for cooling or conditioning purposes (such as dry ice (UN1845) or nitrogen, refrigerated liquid (UN1977) or argon, refrigerated liquid (UN1951)) are not allowed to be sent as **DB SCHENKER | parcel** domestic.

## Finland, Norway and Åland

It is now even easier to send parcels to Europe in our integrated network to Finland, Norway and Åland.

The specific conditions that apply to **DB SCHENKER |** parcel crossborder to Finland, Norway and Åland are shown below.

**Number of parcels per consignment**: Only one parcel per consignment.

**Maximum weight:** 30 kg/parcel and shipment or 70 kg volumetric weight.

**Volume:** Maximum volume/shipment is  $0.25 \text{ m}^3$  ( $1 \text{ m}^3 = 280 \text{ kg}$ ).

**Maximum measurements**: Maximum length/parcel 2.0 m. Length + circumference may not exceed 3.0 m

**Minimum measurements:** Transport labels must fit fully on the top of the parcel, and the height of the parcel must be at least 20 mm.

**Heavy Parcel:** For items heavier than 20 kg actual weight a surcharge will be applied. We recommend, when possible, to split heavy items into smaller parcels under 20 kg.

**Non machine sortable**: In the case a parcels length exceeds 1,4 m or by other reason is deemed not suitable to be sorted by parcel sorting machine, an additional fee for non machine sortable is charged.

**Exceeded product conditions:** For parcels/shipments exceeding the above stated maximum measurements and weight limits, an additional fee is charged (see p. 15).

DB Schenker has no obligation to distribute goods exceeding the above product conditions, and DB Schenker therefore reserves the right to handle such goods in a different way than as stated in these special terms.

**Multi-parcel consignments**: Shipments with more than one parcel will be charged with an additional fee per parcel, apart from the general product conditions.

**Freight haulage weight:** Freight is calculated based on the freight haulage weight, i.e. the higher of the actual weight or the volumetric weight.

**Volume calculation**: The volumetric weight is calculated by multiplying the total volume of the shipment expressed in cubic metres with 280 kg.

**Timetable**: Lead times are available via Connect **DB SCHENKER | system** - Standardleverans

**Exceptions**: Transport to Svalbard and Jan Mayen (NO) as is not available. For transport to vessels and exhibitions in Europe, please contact the DB Schenker Air and Ocean Division.

**Export documents:** For transports to Norway a commercial invoice and documentation required by the customs authority shall be sent to DB Schenker per e-mail. The customs documentation shall also include a summary of commodity codes, lines and value per commodity code.

The consignments can only be booked as consignor freight.

For transports to Norway Combiterms 2020 (0025 – DDP) Delivered to buyer's warehouse/factory declared, excluding customs, VAT and other possible import fees, will be applied between the Customer and DB Schenker in accordance with Combiterms 2020 irrespective of the delivery terms agreed between the seller and the buyer.

For transports to Finland and Åland Combiterms 2020 (0010 – CIP and 0018 – DAP) Delivered At Place will be applied in accordance with Combiterms 2020 between the Customer and DB Schenker irrespective of the delivery terms agreed between the seller and the buyer.

In the case of transport to Åland an additional commercial invoice is required and shall be sent to DB Schenker per e-mail.

By shipping goods with an EU origin and with a value exceeding EUR 6.000 the exporter has to be registered with a Rex-number in order to be able to execute a certificate of origin.

If the value of the consignment is less than EUR 6.000 (approximately SEK 55,000) the export declaration can be made on the commercial invoice. In the case of a higher consignment value, an EUR1 certificate is used. The value of the commercial invoice cannot be zero (0). A statistical number and the value of the goods must be shown.

Consignments to a third country can only be sent as **DB SCHENKER** | **parcel crossborder** according to procedure code 1000, which means regular export.

For consignments to a third country, DB Schenker reserves the right, pursuant to  $\S$  11 and  $\S$  12 of NSAB 2015, to charge the Swedish consignor for the cost of customs and VAT if these are not paid by the consignee.

If information or documents required by customs are missing, the consignment is retained until the information is complete. A double customs clearance charge is then payable.



#### NSAB 2015 and Terms & Conditions of Transport:

The rules in the CMR Convention apply to international parcel consignments, which means a maximum of SDR 8.33/kg (approximately SEK 110/kg) for damaged or lost parcels.

**Extra goods insurance**: If the value of the consignment exceeds the compensation level according to NSAB, it is recommended that extra goods insurance be taken out through DB Schenker in conjunction with the booking.

**Pre-Notice delivery via SMS or e-mail**: Information about scheduled delivery. The consignee will be notified before delivery takes place. Booking of the notification shall be sent electronically to DB Schenker with contact information containing name, mobile phone number and e-mail address to the person who shall be notified.

## Europe (Finland, Norway and Åland excluded)

It is just as easy to send parcels to Europe as it is within Sweden. DB Schenker has a well-developed network in Europe, offering smooth, secure transport for you and your customers.

The specific conditions that apply to **DB SCHENKER** | **parcel crossborder Europe** (except Finland, Norway and Åland) are shown below.

**Maximum weight:** 30 kg/parcel and maximum 99 kg/shipment.

**Volume:** Maximum volume/shipment is  $0.36 \text{ m}^3$  (1 m<sup>3</sup> = 280 kg).

**Maximum measurements**: Maximum length/parcel 2.0 m, maximum width/parcel 80 cm and maximum height/parcel 60 cm. Length + circumference may not exceed 3.0 m

**Minimum measurements**: Transport labels must fit fully on the top of the parcel, and the height of the parcel must be at least 20 mm.

**Heavy Parcel:** For items heavier than 20 kg actual weight a surcharge will be applied. We recommend, when possible, to split heavy items into smaller parcels under 20 kg.

**Non machine sortable**: In the case a parcels length exceeds 1,4 m or by other reason is deemed not suitable to be sorted by parcel sorting machine, an additional fee for non machine sortable is charged.

**Exceeded product conditions**: For parcels/shipments exceeding the above stated maximum measurements and weight limits, an additional fee is charged (see p. 15). DB Schenker has no obligation to distribute goods exceeding the above product conditions, and DB Schenker therefore reserves the right to handle such goods in a different way than as stated in these special terms.

**Export documents:** For transport to a third country (Andorra, Gibraltar, Lichtenstein, San Marino, Switzerland, United Kingdom and Turkey), a commercial invoice in at least 2 copies and documentation required by the customs authority must be enclosed.

Please note specific conditions for Great Britain below.

If information or documents required by customs are missing a double customs clearance charge is then payable.

Consignments to Turkey could also be accompanied by an ATR document.

For transports Combiterms 2020 (0010 – CIP and 0018 – DAP) Delivered At Place will be applied in accordance with Combiterms 2020 between the Customer and DB Schenker irrespective of the delivery terms agreed between the seller and the buyer.

The consignments can only be booked as consignor freight.

It is now just as easy to send parcels anywhere in the world as it is in Sweden. We offer a global parcel network providing simple, secure transport for you and your customers.

**Maximum weight**: 30 kg/parcel and maximum 99 kg/shipment.

**Volume**: Maximum volume/shipment is 0.36 m<sup>3</sup> (1 m<sup>3</sup> = 280 kg).

**Maximum measurements**: Maximum length/parcel 2.0 m. Length + circumference may not exceed 3.0 m

**Minimum measurements:** Transport labels must fit fully on the top of the parcel, and the height of the parcel must be at least 20 mm.

**Heavy Parcel:** For items heavier than 20 kg actual weight a surcharge will be applied. We recommend, when possible, to split heavy items into smaller parcels under 20 kg.

**Non machine sortable**: In the case a parcels length exceeds 1,4 m or by other reason is deemed not suitable to be sorted by parcel sorting machine, an additional fee for non machine sortable is charged.

**Exceeded product conditions**: For parcels/shipments exceeding the above stated maximum measurements and weight limits, an additional fee is charged (see p. 15). DB Schenker has no obligation to distribute goods exceeding the above product conditions, and DB Schenker therefore reserves the right to handle such goods in a different way than as stated in these special terms.

**Multi-parcel consignments**: Shipments with more than one parcel will be charged according to the minimum freight weight of 20 kg. For shipments up to 99 kg, with more than 5 parcels, a parcel supplement of SEK 30/parcel will be charged from and including the 6th parcel.

Freight calculation: Zone pricing applies (see price list)

**Freight haulage weight:** Freight is calculated based on the freight haulage weight, i.e. the higher of the actual weight or the volumetric weight.

**Volume calculation**: The volumetric weight is calculated by multiplying the total volume of the shipment expressed in cubic meters with 280 kg.

**Timetable**: The timetable shows the countries in which we operate around the world (see table on pages 13–14). For distribution of larger consignments and to countries other than those listed in the timetable, contact the DB Schenker Air & Ocean Division.

**Distribution**: The transport times stated in the Zone division on pages 12–13, apply from Swedish postcode areas 10000–61999 and 63000–79999. From other postcode areas, there is one (1) extra transport day.

**Exceptions:** It is not possible to transport to countries subject to an embargo or other international trade barrier. Updated information regarding unlisted countries is available from your local DB Schenker office.

**Export documents and Customs clearance service**: In the case of transport to a third country, a commercial invoice, issued at least in duplicate, must be enclosed together with the documentation stipulated by the customs authority. Official regulations contain specific documentary requirements, which among other things include the following information:

- Details of the consignor and consignee
- Description of the goods and their value
- Country of origin
- Information about customs and VAT liability at the destination.

By booking of transport the consignee's VAT number must be given.

For transports Combiterms 2020 (0010 – CIP and 0018 – DAP) - Delivered At Place will be applied in accordance with Combiterms 2020 between the Customer and DB Schenker irrespective of the delivery terms agreed between the seller and the buyer.

The consignments can only be booked as consignor freight.

**Terms and Conditions of Transport**: The Montreal Convention applies to international parcel consignments outside Europe. In the event of damaged or lost parcels, the maximum compensation payable under the Montreal Convention for goods affected is 19 SDR/kg (approximately SEK 250/kg).

**Extra goods insurance**: If the value of the consignment exceeds the compensation level according to the Montreal Convention, it is recommended that extra goods insurance be taken out through DB Schenker in conjunction with booking.

**Stamping of a Certificate of origin:** SEK 610 Export declaration and customs clearance are included in the freight quotations.

### **Deliveries to private persons - Domestic**

DB SCHENKER | parcel offers three delivery alternatives to private individuals and small businesses - via Parcel Shop, parcelbox or home.

DB Schenker must recive a correct transport order containing all neccessary details. Place your order via your TA/system supplier or via <a href="https://www.dbschenker.com/se">www.dbschenker.com/se</a>

**Parcel Shops** are mainly located where people live or work. Parcels are collected by the consignee at one of the approximately 1,600 DB Schenker Parcel Shops. The service offers flexibility regarding when and where the parcel can be collected. It could be from the Parcel Shop near your place of work or perhaps the one near your house in the country – you decide. The service is ideal for e-business/ mail-order customers where simplicity in handing returns and COD is an obvious element.

DB Schenker collaborates with iBoxen and delivers parcels to iBoxens parcel boxes. The parcel boxes are placed outdoors in residential areas. They are available 24/7 – the consignees can pick up their parcels at their convenience. We deliver to parcel boxes every weekday.

There could be local deviations. For sparsely populated locations the distance is greater to the nearest Parcel Shop. A list of Parcel Shops can be found at <a href="https://www.dbschenker.com/se">www.dbschenker.com/se</a>

**Pre advice**: Pre advice takes place by text message, e-mail, letter or telephone. The choice of pre advice method could differ from one service to another. For further information see the respective service on the following pages.

Collection: Parcels are collected following booking at your nearest DB Schenker office. For bookings made after 12.00 parcels are collected the following delivery day. When less than five consignments are collected on the same occasion a collection charge is payable (unless other DB SCHENKER | system domestic are to be collected at the same time)\* items with a weight below 20 kg and with maximum dimensions corresponding those for DB SCHENKER | parcel Shop can also be submitted on any of DB SCHENKER | parcel shops for a fee of SEK 15 per item.

**Timetable**: The timetable in eSchenker contains the locations/postcode areas we serve as well as current transport times in Sweden.

**Distribution** takes place through the **DB SCHENKER** | **parcel** network, comprising some 1,600 Parcel Shops. Parcel Shops are mainly small stores and filling stations. Our network of Parcel Shops can be seen on our website <a href="https://www.dbschenker.com/se">www.dbschenker.com/se</a>.

**City surcharge**: There will be a city surcharge for consignments to Gothenburg and Stockholm. Does not apply to deliveries via parcel shops or parcel boxes.



**Return flow**: By using a prepaid return label the consignee can return a parcel to the consignor by handing the parcel in at any parcel Collection Point (applies only to Collection Point deliveries and deliveries to parcel box.) The cost is shown in the agreed price list. The return flow leaves the parcel Collection Points on each day stated in the timetable although with extra lead time for handling returned parcels.

**Supplementary conditions**: All goods must be packed so that they can withstand normal machine sorting. Dry ice (UN1845) and substances presenting a risk of asphyxiation when used for cooling or conditioning purposes (such as dry ice (UN1845) or nitrogen, refrigerated liquid (UN1977) or argon, refrigerated liquid (UN1951)) are not allowed to be sent as **DB SCHENKER | parcel**.

**Security:** Before a parcel is handed over the consignee must confirm his/her identity. A parcel can be handed over to a person other than the consignee stated in the address if the person collecting can produce the consignee's identification or their own identification.



### DB SCHENKER | parcel - Parcel Shop

With the Parcel Shop service, we send goods to private persons and small companies in Sweden. The consignee decides when and where delivery will take place. We have around 1 600 Parcel Shops points to choose from.

**Weight**: The maximum weight is 20 kg per parcel.

**Number of parcels per consignment:** Only one parcel per consignment.

**Maximum measurements**: Maximum length/parcel 1.8 m. Length + circumference may not exceed 3.0 m

Volume: Maximum volume is 0.25 m<sup>3</sup>

**Minimum measurements:** Transport labels must fit fully on the top of the parcel, and the height of the parcel must be at least 20 mm.

### **DB SCHENKER | parcel home Crossborder**

With DB SCHENKER | parcel home crossborder, you send parcels to private persons abroad in a safe, simple and fast way. The specific terms and conditions for the parcel home crossborder product are outlined below. In addition to these, the same conditions apply as on page 8 (Europe).

**Maximum weight:** 30 kg/parcel and maximum 99 kg/shipment.

**Volume:** Maximum volume/shipment is  $0.36 \text{ m}^3$  (1 m<sup>3</sup> = 280 kg).

**Maximum measurements**: Maximum length/parcel 2.0 m, maximum width/parcel 80 cm and maximum height/parcel 60 cm. Length + circumference may not exceed 3.0 m

**Minimum measurements:** Transport labels must fit fully on the top of the parcel, and the height of the parcel must be at least 20 mm.

**Heavy Parcel:** For items heavier than 20 kg actual weight a surcharge will be applied. We recommend, when possible, to split heavy items into smaller parcels under 20 kg.

**Non machine sortable**: In the case a parcels length exceeds 1,4 m or by other reason is deemed not suitable to be sorted by parcel sorting machine, an additional fee for non machine sortable is charged.

**Exceeded product conditions:** For parcels/shipments exceeding the above stated maximum measurements and weight limits, an additional fee is charged (see p. 15).

DB Schenker has no obligation to distribute goods exceeding the above product conditions, and DB Schenker therefore reserves the right to handle such goods in a different way than as stated in these special terms.

**Multi-parcel consignments**: Shipments with more than one parcel will be charged according to the minimum freight weight of 20 kg. For shipments up to 99 kg, with more than 5 parcels, a parcel supplement of SEK 30/parcel will be charged from and including the 6th parcel.

Freight calculation: Zone pricing applies (see price list)

Local distribution agreements applies. National or local customs regulations may apply.

Consignee directed deliveries: By shipping to private persons, the consignee can direct the delivery as desired.
